

## BLINDERHUND RANCH SHEEP TERMS

- Lambs
  - lambs are registered with Barbados Blackbelly Sheep Association (BBSAI) prior to sale.
  - Transfer paperwork is completed on day of sale.
  - Buyer provided with copy of paperwork at time of sale.
  - Seller sends transfer paperwork to BBSAI on day of sale.
  - Buyer pays fee for registration \$10 per animal (will discounted for group purchase)
  - Buyer must have an active account/membership with BBSAI to view their registered sheep.
  - It can take up to 1 month for registration to appear on BBSAI site. Any questions, should be directed to BBSAI after date of sale.
  - Confirmation of registration is sent via email to buyer from BBSAI.
  - BHR Sheep are supplemented with organic pellet feed from Coyote Creek as part of their diet (in addition to coastal hay and grazing)
- Prices
  - Ewes \$425
  - Rams \$550
- Waitlist:
  - We currently have a waitlist for registered lambs.
  - Upon lamb birth and tagging, waitlist participants will be notified in the order in which they were placed on the waitlist (Determined by date/time of email receipt). Each participant has 48 hours to respond before rotation to the bottom of the waitlist.

- Terms of Sale:
  - Seller will provide an approximate pickup availability date to the buyer at time of deposit.
  - Seller will provide clean parasite test results from veterinarian at time of transfer.
  - If Buyer requires additional veterinarian services or certificates of health (required for interstate transport) the Veterinarian fees are the responsibility of the buyer and will require an additional deposit to cover both veterinarian and associated transportation costs. All services will be provided by Fayette County Vet, Lagrange TX.
  - If buying a single (1) lamb/sheep from Blinderhund Ranch you must confirm that you have an appropriate companion animal in the paddock/field where sheep will be housed.
  - Seller will notify buyers of lambing and approximate availability dates.
  - Lambs will be weaned at approximately 4 months of age prior to being sold.
  - Blinderhund Ranch Sheep are not necessarily vaccinated.
  - Lambs are scrappie and farm tagged prior to sale.
  - Tag numbers are used for registration and remain assigned with the animal for life.
  - Hooves will be inspected and trimmed if necessary, prior to transfer by seller
  - It is the buyers' responsibility to determine genetic line/lineage for breeding purposes.
- Payment:
  - All deposits are nonrefundable.
  - Payment type: Cash or Credit card.

- 3.5% convenience fee added to all credit card transactions.
  - A purchase deposit of no less than 25% of the sales price will be required to reserve purchase right prior to animal's availability (weaning, parasite testing).
  - The seller retains the right to terminate sale at any time for any reason. Buyer to receive full refund of deposit upon seller cancellation.
  - The buyer has 7 days to pick up reserved animal upon firm notice of availability. Failure to pick up within 7 days of availability notification may result in right to purchase at sellers' discretion; or boarding costs will be incurred.
  - If there are extenuating circumstances- buyer is responsible for contacting seller to determine if holding, fees for boarding etc. are applicable.
  - If buyer is unable to purchase animal, deposits paid are non refundable.
- Transport
    - Buyer is responsible for proper transport, related costs, paperwork etc. Blinderhund Ranch will not allow a sheep to leave the premises without means of proper transportation (travel Trailer, Travel Pen etc)
    - Seller must be notified If buyer is using a transportation company in advance.
    - A signed written statement by the buyer will need to be presented by transporter if buyer is not present at time of pick up.
    - If buyer is not present at time of pickup, seller will send necessary transfer paperwork via email prior to transport.
